

Analysis & Response - Phase

During the Analysis phase of a POP project, personnel (crime analyst, officer, etc.) work to detail the five W's. The primary objectives of analysis are to narrow the scope of the problem, to identify contributing factors, to evaluate prior strategies for dealing with the problem, and to look for intervention opportunities.

- Who is involved.
- What the problematic behaviors and harms are.
- When the incidents are happening.
- Where they are occurring.
- Why factors that are contributing to the problem.
- **How** does the community expect law enforcement to address issues.

In the Response phase, efforts are taken to form partnerships with key stakeholders, generate and weigh possible interventions, and then implement the selected strategy(ies).

Analysis & Response Phase: Community Survey

Learn more about traffic safety problems that concern community members.

- Narrow focus within target problem
 - Type of problems (e.g., speeding, DUI, tailgating)
 - Contributing factors
- Identify geographic hotspots
 - High risk locations
- Identify temporal patterns
 - Day of week & time of day
- Generate ideas for improving traffic safety.
- Assess support for interventions already under consideration.




Top Concern for bikers, drivers, and walkers in Sara City.

- Aggressive/ distracted drivers
 - People drive too fast, feeling that drivers are impatient with bikers, drivers are rude to people walking.
- Poor road design & maintenance
 - Not enough cross walks, construction zone contributing to traffic problem, there are no established bike lanes.




Top Suggestions:

Analysis & Response Phase: Community Survey

- Most residents feel safe driving & walking in city.
- Perceived safety for biking is lower.
- Geographic pattern emerges.
- Area of concern for bikers, walkers, drivers 3
 & 9.
- High agreement on what problem is.
- Distracted driving, aggressive driving, and speeding.
- High support for interventions.
 - Increased enforcement of driving infractions, roadway redesign.
- Low support for interventions.
 - Lower speed limits & citation of pedestrians.

Do Not Re-invent the Wheel



- Some, even most, of the topics you want to include in your survey may have been covered in prior surveys.
- Look for other community surveys on the Internet, as many other agencies and cities have surveyed their communities about crime and policing.
- Search academic literature using an online tool like Google Scholar (Can come with a lofty fee if you're not within academia or with an academic partner).
